

ASSP Introduces Virtual Safety Education Series

ASSP will launch its virtual safety education series on Aug. 26-27 with SafetyFOCUS: Construction, putting participants at the forefront of topics such as fall protection, silica standards, crisis management, contractor prequalification and job hazard analysis. Construction has one of the highest injury and fatality rates of any industry sector.

The virtual education series will deliver relevant safety and health information that attendees can immediately implement in their organizations. Additionally, participants will earn continuing education units (CEUs) to help maintain their professional certifications.

Over the next several months, the SafetyFOCUS virtual education series will feature events on safety management systems on Sept. 16-17; risk assessment and management on Oct. 20-21; industrial hygiene on Oct. 22; business skills and leadership on Nov. 17; human and organizational performance on Nov. 18-19; standards on Jan. 26; ergonomics on March 9; and training and education on March 10-11.
